You will advise and contribute to UN systems coordination through participation in UN interagency groups and task forces, policy dialogue and provision of inputs into joint common system initiatives.

You will be reporting to the UNFPA Representative and you will act on his/her behalf as required.

# You would be responsible for:

- Conducting policy dialogue with Government, UN and other development partners to incorporate UNFPA's priorities and agenda into national plans and strategies, and UN systems, initiatives and development frameworks.
- Translating global strategies into country-specific advocacy strategies. This includes creating and
  delivering evidence-based advocacy messages to promote UNFPA's programme goals, taking into
  account political and social sensitivities.
- Promoting a results-based approach, integrating innovative policies and strategies into the design and formulation of country programmes, sub-programmes and projects. You will ensure programmes are responsive to the country's needs in areas of UNFPA's strategic priorities.
- Facilitating the achievement of programme results by identifying, providing and coordinating inputs into programme development and implementation, ensuring programme monitoring and oversight, and coordinating and evaluating the inputs of consultants and technical experts.
- Promoting knowledge sharing and continuous learning including testing, evaluating and
  documenting innovative strategies and best practices internal and external to UNFPA, and
  integrating these as appropriate.
- Contribute to resource mobilization efforts by identifying potential donors, preparing proposals including outlining co-financing resources for support to the country programme, and supporting the government and other agencies in coordinating assistance for programmes.
